Dear Judge Houston

My name is Peter Walker and I am a British citizen living in Cologne Germany involved in European Research into the microscope and resonance therapy inspired by the San Diego scientist, Royal Raymond Rife. I have been personally involved in independent research into Rife technology since 1993 and in that time, I have built up a large research reference website www.rife.de, an online Rife Forum with about 6000 members (<http://www.rifeforum.com>), the Rife Yahoo group community with over 2700 members (<http://health.groups.yahoo.com/group/Rife/>) and the Rife Wiki which is a non-profit Rife related Wikipedia as a public service for the Rife community. I am regarded highly by the members of the Rife Research community worldwide for the various factual platforms on Rife technology I have built up. I do not market any kind of Rife equipment and also do not treat anybody. This allows me to be independent of all device manufactures and stand up for free speech and truthful reporting about the technology. I do not work for any of the device manufacturers at all. I am involved with marketing the German Ergonom microscope system which is partly inspired by the original Rife microscope and is technically superior to it (<http://www.grayfieldoptical.com>). I also provide technical support to Dr. Nengah Sylver, PhD who has written an excellent 760-page eBook on Rife technology called The Rife Handbook of Frequency Therapy with a Holistic Health Primer (www.nenahsylv.com). Nengah is also not associated with any device manufactures.

With this background, I am qualified to give you my opinion on Rife technology and my exchanges with Jim Folsom who I have been in contact with for many years (as I am in contact with all prominent people in the world of Rife research).

First of all, let me tell you something about Rife therapy over here in Europe. Here in Germany, where I have been living since 1978, Rife therapy is perfectly legal and openly practiced by therapists throughout the country with good results. There are a number of European manufacturers of such devices and they all have European med CE certification as Class IIa, rule 9 medical devices (European equivalent of FDA approval). As far as I am aware, some of Jim Folsom's units have such European certification and can be legally and openly sold and used here by both therapists and patients.

One such European company, here in Germany, produces a similar unit to that Jim Folsom was marketing in the USA. The BioWave 77 unit (made by the company Medi-gen), is fully certified according to med CE class IIa as a medical device (equivalent to FDA approval, yet in Europe) and is widely used in both conventional and natural medicine clinics throughout Germany and many other European countries. These units have been highly effective in treating a large number of diseases often untreatable with conventional methods. Such units are seen to be especially effective in the treatment of Lyme disease, for example. I have personally attended and was a guest speaker at a Rife Congress held by this company in 2008 (http://www.rife.de/rife_congress_2008.html) and had the opportunity to talk to hundreds of therapists from many European countries that were successfully using this equipment. Many thousands of these units have been sold both openly and legally within Europe.

Another European company, called Oncotherm (www.oncotherm.org), has incorporated a further development of Rife frequency modulation into their hyperthermia equipment which is used in mainstream cancer clinics and hospitals in many European hospitals and they have performed clinical trials proving the effectiveness of “Rife modulation” in the treatment of cancer. Many thousands of patients have been treated this way with results proven in clinical trials to be significantly superior to just classic chemotherapy, surgery and radiotherapy.

As I am well known in the Rife world, I receive positive reports from patients using Rife technology almost every day for a wide range of different modalities. I attend numerous medical conferences and trade fairs; including Medica which is the world’s largest medical equipment trade fair (www.medica.de) held in Germany, where many manufactures of Rife-like frequency therapy devices can be found made by companies like Medi-gen, Oncotherm and GBO, which is the medical arm of Siemens.

I am constantly talking with doctors and naturopaths here in Germany about the technology and one commonly heard comment is that it is somewhat bewildering that in the USA, a country which is normally symbolic for encouraging freedom, should be suppressing Rife therapy, when it is used so successfully over here in Europe. These German practitioners have been observing a steady stream of American citizens flying to Germany for such treatment.

If Jim Folsom were living and working here in Germany, his business and equipment would have been perfectly legal according to European law. I know a number of companies, here in Germany, manufacturing similar “Rife” devices very successfully.

There have been a number of published scientific articles showing the effectiveness of frequency therapy in the treatment of a wide range of diseases. It is interesting to note that the FDA has approved a very similar technology for food processing as outlined on the papers quoted here: http://www.rife.de/fda_approved_food_processing.html

Jim Folsom

I have been in contact with Jim Folsom a number of times over the past few years including at my visits to the yearly Rife Conference in Seattle (I was a speaker at that conference 3 times).

I always found him to be an open, honest and caring person who was really dedicated to helping people any way he could.

I basically run the Rife online community and there have been 40856 posts to date, on the forums I have run since September 1999 (Rife Yahooogroup – formally onelist.com, Rife Forum opened in September 2002) until the present. A history of Rife online communities can be found at http://www.rifewiki.org/wiki/History_of_Rife_Communities . In all those years, I have never seen even one negative comment about Jim Folsom. This shows that he has built himself a solid reputation for honesty and reliability over the years.

Pending destruction of Historic Rife Equipment

I am greatly concerned to hear about the prosecution's application to destroy original Rife equipment that Jim Folsom had in his possession. Such equipment is extremely rare and valuable to the history of resonance therapy equipment and, if anything, should be donated to a museum. I strongly feel that this historic equipment should be returned to Jim Folsom so that it can be donated to a museum like the London Science Museum or perhaps the Smithsonian Institute in the USA.
